TERMS & CONDITIONS FOR HIRING OF VEHICLES

The following terms and conditions must be fulfilled be the successful bidder for providing a vehicle on hire on monthly rent basis.

- 1. The hire vehicles, during period of contract, shall have all necessary valid MV documents such as valid Registration Certificate, Insurance Certificate, Fitness Certificate, valid contract carriage Permit, proof of up to date Tax payment etc. and D.L. of the driver available all the terms.
- 2. The department/ Office hiring the vehicle shall not be responsible for any damage/ loss caused to hired vehicles or loss of life/injury made to any person or damage to any property on account of use of hired vehicle any manner whatsoever. The hirer shall be responsible for all such ligation.
- 3. The hire charges to be paid for monthly basis is final but does not include cost of diesel, which is to be paid separately basing on actual consumption and lubricants as per existing Government norms. All the expenditure of the Vehicle towards repair, replacement of spare part, Lubricating oil of Engine, Gear Box & differential Coolant, Tyres & tubes, Battery etc. will be borne by the bidder.
- 4. It shall be the responsibility of the bidder to provide a good driver and salary of the driver shall be borne by the owner.
- 5. In case of breakdown for reason whatsoever the replacement of a Vehicle of the same or better model shall be provided by the owner of the vehicle/bidder.
- 6. The Vehicle shall be available all the time. In case the vehicles do not report regularly, the authority will be at liberty to reject the agreement and may engage vehicle from other source.
- 7. The Vehicle cannot be used for any private/commercial purpose beyond office hours or during holidays and if in any case it is detected, the contract can be terminated and penalty @5% of the agreement value will be realized/adjusted against the pending claim along with forfeiture of security money.
- 8. The selected bidder shall furnish security deposit @5% of the annual agreement value in the form of BG/NSC/Cash deposits etc. pledged/deposited in favour of the DDO-cum-EO, NAC, Khariar Raod.
- 9. In case of emergency, the driver will have to report for duty as per the requirement of hire. No extra payment shall be demanded.
- 10. Monthly hire charges and reimbursements towards cost of diesel (as per actual) and lubricants (as per Govt. norms) of selected bidder will be paid in every succeeding month, as per as possible within fifteen days of the submission of bills by the service provider and no advance payment will be made.
- 11. The Vehicle shall not be more than 3 years old from the registration and also in good running condition during the period of contract.

- 12. If the services are found to be unsatisfactory, the client shall give one month notice and terminate the agreement.
- 13. In case the service provider intends to withdraw the services of his vehicle and terminate the agreement, it shall be mandatory upon him to grant one month notice before such withdrawal of service and termination of agreement.

14. If the bidder violates any of the terms of contract, Government shall forfeit the entire amount of security deposit.
